## MINUTES OF THE MEETING OF THE BOARD OF SUPERVISORS OF THE HOWARD BEND LEVEE DISTRICT

## September 18, 2018

A meeting of the Board of Supervisors (the "Board") of the Howard Bend Levee District (the "District") was held on Tuesday, September 18, 2018 at 7:30 a.m. at the offices of Creve Coeur Airport, 14301 Creve Coeur Airport Road, St. Louis, MO 63146.

The Supervisors participating in the meeting were Warren Stemme, Gary Hente, Jeff Wagener, Darel Knobbe, Jim Carver and Ed Ortmann. Executive Director of the District Dan Human, Accountant for the District Suzanne Gaal-Chablotz and District Engineer Karen Frederich along with Jim McLeish were present. Also participating were David Human, David Human Jr., and JoAnn Sandifer as counsel for the District. Next Karen Frederich discussed the ongoing construction of the Fee Fee Creek North Flank Levee. In particular the Board discussed Kolb's proposal to raise the Levee to the 500-year level of protection.

Next Karen Frederich and Jim McLeish discussed a proposed Stakeholder Engagement and Communication Plan whereby the District would employ Jim Randolph of Horner & Shifrin to communicate with Maryland Heights regarding current engineering and assessment issues.

Next Suzanne Gaal-Chablotz reviewed the financial statements and outstanding invoices. Upon motion by Jeff Wagener, seconded by Ed Ortmann, the Board unanimously approved a motion to pay the Bills as presented.

Upon motion by Ed Ortmann, seconded by Jeff Wagener, all in favor, the Board elected Warren Stemme President of the District and Gary Hente Secretary of the District.

Warren Stemme made a motion the Board go into closed session to discuss personal, real estate and litigation matters pursuant to Section 610.021.
